INVITATION TO TENDER: SUPPORTING THE ARTS & CREATIVITY IN EARLY YEARS HIGHER EDUCATION

Background

Norfolk & Norwich Festival

Norfolk & Norwich Festival is the flagship arts festival for the East of England with a reputation for innovative and inspirational programming and commissioning. One of the big four UK international arts festivals, each May we transform and celebrate our city and county through an internationally acclaimed programme of music, theatre, literature, visual arts, circus, dance and outdoor arts, enjoyed by over 75,000 people.

Festival Bridge

Festival Bridge is one of the ten national Bridge organisations with investment from Arts Council England and the Department of Education. Our mission is to ensure children and young people across Cambridgeshire, Norfolk, Peterborough and Suffolk know that arts and culture belong to them. Festival Bridge is part of Norfolk & Norwich Festival.

Specification

Background

One of Festival Bridge's key strategic areas of development is to enhance the creative experiences of babies and children in their early years (0-5 years). This is a two-pronged approach: on the one hand, through support for artists to develop specialist skills in working with this age group, and on the other to increase the skills and confidence of early years practitioners to widen their own creative practice within their settings.

The impetus for the former came from a scoping report undertaken on Festival Bridge's behalf by AYCORN East (a collective of artists specialising in this age group now formally constituted as Magic Acorns). (See https://nnfestival.org.uk/festival-bridge/what-we-do/research-development/early-years/ for the original report and further principles for arts and early years.)

Alongside the artist development work now being led by Magic Acorns, Festival Bridge has been leading on ways to embed additional skills within the early years workforce itself, partly through CPD for practitioners (being piloted through Highfield Nursery in Ipswich with funding from Youth Music) and partly through partnership with higher education institutions.

For the latter Festival Bridge has built a partnership with Anglia Ruskin University to pilot artistic input into their Early Years Education Foundation Degree curriculum. Most students undertaking this two year foundation degree are existing early years' practitioners, and much of the module is delivered remotely – following the current Covid-19 emergency, all teaching will be online for the next academic year. Students in their second year will build this work into their Work-Based Learning Module (See Appendix 1 for the full proposal).

Aims of the consultancy/evaluation

Festival Bridge is now seeking an experienced evaluator to measure the impact of this initiative and to refine its potential going forward. The evaluation will examine

- the efficacy of the delivery
- the impact on students' skills base, confidence and academic achievement and
- the management of the partnership between Festival Bridge and the artistic partners.

The ultimate purpose of the evaluation will be

- to provide the partners with evidence of additionality to the existing curriculum model
- to support the potential for embedding this initiative as part of a much larger in-depth research project funded by AHRC or larger Foundations that support educational development.

Approach

We would like bidders to propose an evaluation approach using quantitative and qualitative methods, and provide the skills and experience necessary to complete the project described above. We expect there to be consultation with the partners and a close and flexible working relationship with the Head of Bridge at Norfolk & Norwich Festival.

Outputs

- Project management and quality assurance
- Interim evaluation report
- Final evaluation report

A final meeting with project partners to share and discuss findings.

- 3. Provide copies of CVs for the delivery individual/team and two references for relevant previous projects
- Include a detailed budget, complete with a schedule of charges (estimated number of days). The total fixed price will be exclusive of VAT and inclusive of expenses and all costs to be incurred.

LEARNING, TEACHING AND ASSESSMENT INFORMATION

6a. Module Description

Building on the experience of Work Based Learning 1, students will be encouraged to continue exploring their professional/occupational practice, along the strands developed previously, as a source of learning. In this module, students will be expected to demonstrate greater degree of autonomy in management of their learning and ability to analyse and evaluate both information and argument. Students will be required to apply theory to practice. As part of the module, students will devise a suitable programme of work-based activities intended to develop both practical competence and understanding of the principles that underpin such practice. Students will be required to propose a plan of work and rationale showing that they have made informed decisions about their intended learning. Students will be responsible for maintaining effective communication with both their identified Mentor/Key Worker in the work-place and their Supervising Tutor.

Having planned, agreed, implemented, completed and presented the project report, students will critically appraise the learning gained against appropriate professional and academic targets. Throughout the module, students will develop both specific skills relating to their role within their organisation and the transferable skills of planning, negotiation, record-keeping, self-evaluation and reflection. This module can be delivered in a variety of modes: Blended or fully online. Students need to submit an electronic portfolio (patchwork text) for assessment. All key resources will be available online. In addition, many key resources will be work context specific and defined during the planning of the learning activities, with the support of the tutor.

Patchwork text will be based on (a) the theoretical account of student's work, (b) the plan of work that the student develops with the help of mentor and supervising tutor and (c) presentation, to allow students to share the findings of their work with a wider audience. There will be opportunities for peer and tutor formative feedback for patches and presentation work. All patches are submitted together as one e-portfolio, including findings of project work. Assessment, therefore, will be in the form of an Electronic Portfolio.

6b. Outline Content

Planning to include consideration of how the following elements are dealt with in the work setting: - Project/ task planning - Action enquiry - Effective team working - Review and development of own professional/occupational practice and academic learning activities – Analysis of practice based evidence

- Self-appraisal and critical reflection.
